Prospective bidders should have key personnel and equipment (listed in the personnel and equipment requirements) available for the prosecution of the contract and must have an experience or completed a contract that is similar to the contract to be bid of at least 50% of the ABC.

All particulars relative to bid security, performance security, pre-bidding conference, evaluation of bids, post-qualification and award of contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations.
